NEXT GENERATION SCHOLARSHIP INFORMATION

THE NEXT GENERATION SCHOLARSHIP will provide qualified students at the Vermont State Colleges with significant assistance in meeting their tuition costs. Awards are 50% of tuition, up to an annual maximum of \$ 2,500. *There will be a rolling application process.*

STUDENTS MUST:

- Be a Vermont resident;
- Be enrolled for the first time as a degree student at CCV, part or full-time;
- Be enrolled in a degree program;
- Demonstrate financial need by completing the financial aid application process;
- Satisfy the College's good academic standing criteria;
- Be eligible for up to 60 credits;
- Have college-level skills in reading, writing and arithmetic. (Accuplacer scores: reading = 85 or above; writing = 85 or above; arithmetic = 66 or above). College-level skills in algebra are not required. Students needing basic algebra will be eligible to apply for this scholarship, but should plan to take the basic algebra course as soon as possible.

ONCE AWARDED, ELIGIBILITY CAN CONTINUE FOR UP TO 60 COMPLETED CREDITS AS LONG AS THE STUDENT:

- After the first semester of full-time enrollment, maintains full-time enrollment in a degree program in college-level courses (e.g., no basic skills courses) for the fall and spring semesters;
- Successfully completes 12 credits in the immediately prior semester;
- Maintains good academic standing and, if receiving federal financial aid, good satisfactory academic progress;
- Continues to demonstrate financial need.
